Thomson Three

1. The coach shall forward to the Management Office, his/ her approved coaching certificate/s. Decision to approve/disapprove the application rests solely with the Management whose decision shall be final.
2. Lessons can only be carried out during the time-periods as approved by the Management as shown below.

Mondays to Fridays : **9am to 6pm**
Saturdays and Sundays/ : **No lessons except prior written approval**
Eve and Public Holidays : **from the management**

3. All students must be residents of **Thomson Three**. A list of students must be submitted to the management office upon application. The number of students shall be restricted to not more than 4 at any one time for swimming lessons, and not more than 1 at any one time for gym lessons.
4. The coach shall notify and update the Management on a monthly basis of his/ her student detail.
5. The coach shall inform the Management of any change in time and day of his / her lesson.
6. The coach is not allowed to solicit business or mail drop any advertising leaflet without prior permission of the Management.
7. No diving or snorkelling lessons are allowed to be conducted in the pool.
8. Proper sports attire deemed acceptable by the Management shall be worn at all time by the coach and students when using the facilities.
9. The coach or his/ her student shall not use the facilities upon knowledge that themselves or his / her student is suffering from open wound infections or contagious disease.
10. The coach shall be responsible for the behaviours of their student(s) at all times.
11. Swimmers are not allowed in the pools when cleaning is in progress.
12. The coach shall notify the Management when he/ she ceases his / her coaching lesson in the Condominium.
13. The Management reserves the right to revoke permission granted without assigning any reason whatsoever and such decision shall be final and not subjected to challenge.
14. The Management reserves the right to terminate the permit given to him/her at any time without prejudice to its rights to take legal action against the coach upon any breach of the above conditions.
15. The Management reserves the right to amend, alter and or/or add to the conditions contained herein. Notice of any change of conditions will be provided to the coach for his / her knowledge and conformance.
16. The coach shall keep the Management indemnified against all actions, claims and demands that may be lawfully brought or made against the Management by any person or persons by virtue or anything done by the coach in exercise of rights and liberties hereby granted.
